

## THE FUTURE OF MEMBERSHIP PRIZE – TERMS AND CONDITIONS

1. This is a game of skill. Chance plays no part in determining the winner. Each entry will be individually judged, based upon individual merit.
2. Employees of the promoter (AuSAE) and agencies associated with this promotion (XYZ University LLC) are ineligible to enter the competition, as are their immediate families, and commercial partners.
3. To enter, entrants must:
  - i) have purchased an eligible\* registration to the “The Future of Membership” workshop in either Sydney (3 December 2018) or Melbourne (6 December 2018)
  - ii) attend the full day workshop
  - iii) On conclusion of the workshop complete the entry form answering the question in 25 words or less “Tell us how you could change your association’s future by attending the 2019 ASAE Annual Meeting in Columbus, Ohio” Only one entry is permitted per person. The Promoter reserves the right to verify the validity of entries.
4. The judges reserve the right to disqualify any entrant submitting an entry which, in the opinion of the judges, includes objectionable content, including but not limited to profanity, nudity, potentially insulting, scandalous, inflammatory or defamatory images or language. The judges' decision will be final and no correspondence will be entered into.
5. All entries become and remain the property of the promoter and agencies associated with this promotion (AuSAE and XYZ University).
6. The winner of the competition must be 18 years old and over and residents of Australia.
7. The promoter reserves the right to withdraw or amend the competition as necessary due to circumstances outside its control.
8. The prize is non-transferable and non-redeemable for cash. Any attempt to resell or auction all or any part of this prize will result in an immediate cancellation of the prize. If, for any reason whatsoever, a winner does not take an element of the prize at the time stipulated by the promoter then that element of the prize will be forfeited by the winner and cash will not be awarded in lieu of that element of the prize.
9. Prize cannot be gifted to other persons in lieu of the winner not being able to travel. Should the winner not be able to complete all aspects of the itinerary within the period of prize validity, the remaining items shall be forfeited without any replacement for their value. Prize winners will be required to agree to and sign the XYZ University promotion conditions when accepting the prize otherwise the prize will be forfeited.
10. The winner is required to obtain the relevant & suitable travel insurance at their own expense in order to be able to take the competition prize. It is the traveller's personal responsibility to ensure that they have valid documentation, including but not limited to; Valid passports, visas, and health requirements, which meet the requirements of immigration and other government authorities at every destination. Any fines, penalties, payments or expenditures incurred as a result of such documents not meeting the requirements of those authorities will be the sole responsibility of the traveller.
11. Once prize has been confirmed by XYZ University, the prize is deemed non-transferrable.
12. On acceptance of the competition prize, the winner acknowledges that they have read and agreed to the promoters booking conditions.
13. Prize includes 1 x return economy flights ex SYD/MEL, 4 nights accommodation and delegate registration to the ASAE Annual Meeting in Columbus, Ohio August 10-13, 2019. Any Additional spending money, flights, meals, insurance, taxes, passports, visas, extra

accommodation, items of a personal nature, inoculations, travel to and from departure point, additions to stipulated itineraries and offered flights and all other ancillary costs are the responsibility of the winner. Unless expressly stated, all other expenses become the responsibility of the winner.

14. The promoter shall not be liable for any loss or damage whatsoever which is suffered (including, but not limited to, indirect or consequential loss) or for personal injury which is suffered or sustained, in connection with the prize, except for any liability which cannot be excluded by laws.
15. The prize winner must be available to travel and attend the ASAE Annual Meeting during the specified time period (August 10-13, 2019). Inability to travel on these dates will result in the forfeiting of the prize by the winner. No cash will be offered in lieu of the prize.
16. Promotion commences 28 November 2018. Entries open immediately following the conclusion of the workshop in Sydney on 3 December 2018. Entries close 5pm 14 December 2018.
17. By entering the competition, all entrants will be deemed to have accepted and agreed to be bound by these rules.

19. The information you are asked to provide to AuSAE is personal information and is protected by the Privacy Act 1988. AuSAE will not disclose this information to other parties other than in accordance with the Privacy Act 1988.
20. All entries become the property of the promoter and the XYZ University. The promoter and XYZ University may use the entrant's names and entry information for any commercial purpose, including future promotional marketing and publicity purposes.
21. Independent financial advice should be sought as tax implications may arise as a result of accepting the prize.
22. In the event that for any reason whatsoever a winner does not accept the prize at the time stipulated by AuSAE or XYZ University then the prize will be forfeited by the winner and cash will not be awarded in lieu of the prize.

25. If XYZ University or AuSAE are unable to contact the winner within 30 days of the draw and every effort have been made to contact them with the information provided by the entrant, then XYZ University will award the prize to another valid entrant.
26. By entering, all entrants 'opt-in' consent to have their contact details (title, first name, surname, email, mobile or landline phone number, mailing address and post-code only), released to XYZ University and receiving ongoing marketing material and correspondence from XYZ University and AuSAE.
